

The Abt Electronics Scavenger Hunt Sweepstakes Rules

- 1. ELIGIBILITY:** The Abt Electronics Scavenger Hunt Sweepstakes (the "Sweepstakes") is open only to legal residents of the (50) United States and the District of Columbia over the age of 18. All employees of Abt Electronics, participating Vendors and all associated agencies and each of their respective affiliates, sales representatives, distributors, licensees or agents (all of the foregoing, together with Vendors, collectively referred to as "Sweepstakes Entities"), and their immediate family members (spouse, parent, child, sibling and their respective spouses) and those living in the same household of each (whether related or not), are ineligible to participate in the Sweepstakes. All applicable federal, state and local laws and regulations apply. Void where prohibited or restricted by law.
- 2. SWEEPSTAKES PERIOD:** The Sweepstakes entry period begins at 9:00 a.m. CDT on June 20, 2011 and ends at 5:00 p.m. CDT on June 27, 2011 (the "Sweepstakes Period"). The winners will be selected from entries properly submitted and timely received during the Sweepstakes Period.
- 3. SWEEPSTAKES ENTRY INSTRUCTIONS:** There is NO PURCHASE NECESSARY to participate in the Sweepstakes. A purchase does not increase your chances of winning. A secret word will be scrambled and each day a letter will be revealed. Along with the letter will be an opportunity to win more prizes. Limit: Each participant may receive a maximum of one (1) Application entry daily during the Sweepstakes Period. Use of computer programs and other automatic means to enter the Sweepstakes is prohibited and will result in disqualification. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void such entries and that entrant may be disqualified. Normal Internet access and usage charges imposed by your online service may apply. Sponsor and/or its Administrator (as identified in these Official Rules) are not responsible for the failure of any email or entry to be received by Sponsor/Administrator on account of technical problems or congestion on the internet or at any website. The Sponsor reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or Application; violates the Official Rules; or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes or Application may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. If, for any reason, the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes or Application, then the Sponsor reserves the right at its sole discretion to cancel the Sweepstakes and select the applicable winners in a random drawing from among all eligible entries received prior to cancellation. By participating in the Sweepstakes, the entrant agrees that Sponsor, Administrator, their respective parents, subsidiaries, affiliated companies, agents, retailers, advertising and Sweepstakes agencies, and all of their respective shareholders, officers, directors, employees and assigns, members, representatives and agents, will have no liability whatsoever for, and will be held harmless by entrant for any liability for any bodily injury, loss, cost or damages of any kind to persons, including death and property, damages sustained due in whole or in part, directly or indirectly, from entry creation, the acceptance, possession, use or misuse of the prize or parts thereof, if applicable or participation in the Sweepstakes or participation in any Sweepstakes or related activity. By entering the Sweepstakes, you hereby represent and warrant that you have read these Official Rules and are fully familiar with its contents.
