

Abt Electronics, Inc. – Share Your Game Day Gear and LG TV Giveaway – Official Rules

1. Disclaimer: NO PURCHASE NECESSARY to participate or win. A purchase does not increase your chances of winning. All federal, state, local, and municipal laws and regulations apply. VOID WHERE PROHIBITED, taxed and/or regulated. Abt Electronics, Inc. (“Sponsor”) does not own any logos or other intellectual property used by it, or by any entrant, in connection with this Giveaway, including, but not limited to, the intellectual property of LG, Twitter, Facebook, and Instagram.

2. Eligibility: The Abt Electronics, Inc. Share Your Game Day Gear and LG TV Giveaway (“the Giveaway”) is open to any legal resident of the fifty (50) United States and the District of Columbia, excluding Puerto Rico, who is 18 years or older at the time of entry and who is located in the United States. All employees of Sponsor, participating vendors, and all associated entities and each of their respective affiliated companies, subsidiaries, sales representatives, distributors, licensees, or agents, and the immediate family members (spouse, parents, child, sibling(s) and their respective spouses) of, and those living in the same household (whether related or not) of all employees of the foregoing entities, are not eligible. Each entrant who submits an electronic entry must be the rightful owner of the profile and/or account identified in the entrant’s entry at the time of registration. Entry: The Giveaway will begin at 12 p.m. (CST) on February 1, 2016, and all entries must be received by Sponsor no later than 11:59 p.m. (CST) on February 8, 2016 (the “Giveaway Period”).
Sponsor’s computer will be the official time clock for the Giveaway.

3. How to Play: To participate in the Giveaway, the entrant must have an account with any of the following—Twitter, Facebook, or Instagram—or access to the United States Postal Service. A total of four (4) entries per entrant may be submitted: Twitter (1); Facebook (1); Instagram (1); and the United States Postal Service (1).

- **To enter using Twitter, Facebook, and/or Instagram:** the entrant must post a photograph of his or her TV setup and/or football gear in connection with the text **#abtgametime** and the tag **@abtelectronics.com**. One (1) entry via each site may be submitted. Any entrants who are determined by Sponsor, in Sponsor’s sole opinion, to have created and/or utilized multiple accounts on any of the above-listed sites to submit multiple entries via that site will be deemed ineligible.
- **To enter via the United States Postal Service:** the entrant must mail a letter to Sponsor at the address provided in Rule 7. Such letter must include the entrant’s full name, mailing address, and phone number, and include a photograph of the entrant’s TV setup and/or football gear. One (1) entry is allowed through this method of entry.

All entries—regardless of entry method—must be received by Sponsor no later than 11:59 p.m. (CST) on February 8, 2016.

4. General Rules: By participating in the Giveaway, entrants agree to be bound by these Rules. In the event that there is a discrepancy or inconsistency between disclosures or other statements contained in any Giveaway materials, the terms and conditions of the Rules shall prevail, govern, and control. 7. **Winner Notification and Acceptance:** Winner will be notified via e-mail or phone, depending on the method of his or her winning entry. On or about February 9, 2016, Sponsor may post the winner's first name, last initial, and home city/state on the Giveaway landing page located on Sponsor's website (www.abt.com), and use social media channels to post this information, after the winner has been notified and his/her eligibility confirmed. Return of prize notification as undeliverable may result in disqualification, and an alternate winner may be selected. Winner may waive his/her right to receive the prize.
