Fujitsu General America, Inc. (FGAI) warrants that this product conforms to the manufacturer's specifications and will be free of defects in material and workmanship and should any defect occur Fujitsu General America, Inc. will correct the defect subject to the following conditions:

LABOR: For a period of **three (3) years** from the date of sale to the original consumer, FGAJ will pay for services labor by an FGAJ Authorized Service Center.

PARTS: For a period of **three (3) years** from said date of sale FGAJ will supply new, or at its option rebuilt replacement parts.

PDP (Plasma Display Panel): For a period of **three (3) years** from said date of sale FGAJ will supply new, or at its option rebuilt replacement PDP.

PROOF OF PURCHASE: Copy of the proof of purchase from an **authorized dealer** is required to make this warranty valid.

WARNING

THIS WARRANTY IS VALID ONLY IF THE PLASMA DISPLAY MONITOR WAS PURCHASED NEW FROM AN AUTHORIZED DEALER AND THE ORIGINAL FACTORY SERIAL NUMBERS OF THE PLASMA DISPLAY MONITOR HAVE NOT BEEN REMOVED, DEFACED OR REPLACED IN ANY WAY. Authorized dealers are not allowed to sell the plasma display monitors on the Internet, through an online retailer or any similar e-tailing website. Any units purchased on the Internet, from an online retailer or any similar e-tailing website, or whose serial numbers have been removed, defaced or replaced in any way are deemed to have been purchased used or from an unauthorized dealer and not covered by this warranty.

Fujitsu General America sells products through authorized channels to ensure the highest quality product and pre and post sale support and service.

THIS WARRANTY DOES NOT COVER:

- Shipping damage.
- Unpacking and/or removal of protective shipping material.
- Service required as a result of improper installation, incorrect or insufficient AC supply voltage.
- Installation, set up, or adjustments of consumer controls.
- Any owner than the original consumer.
- Damage from modification or incorporation into other products.
- Any failure, loss, damage or personal injury due to accident, neglect, or abuse by the consumer or to improper operation, maintenance or storage or to alteration or to failure to follow normal procedures as outlined in the owner's manual. **This includes burn-in.**

- Usage for Commercial applications.
