

## Abt Electronics, Inc. – Review & Win Sweepstakes – Official Rules

**1. Disclaimer:** NO PURCHASE NECESSARY to participate or win. A purchase does not increase your chances of winning. All federal, state, local, and municipal laws and regulations apply. VOID WHERE PROHIBITED, taxed and/or regulated. Abt Electronics, Inc. ("Sponsor") does not own any other logos or other intellectual property used by it, or by any entrant, in connection with this Contest.

**2. Eligibility:** The Abt Electronics, Inc. Review & Win Sweepstakes ("the Contest") is open to any legal resident of the fifty (50) United States and the District of Columbia, excluding Puerto Rico, who is 18 years or older at the time of entry and who is located in the United States. All employees of Sponsor, any participating vendors, and all associated entities and each of their respective affiliated companies, subsidiaries, sales representatives, distributors, licensees, or agents, and the immediate family members (spouse, parents, child, sibling(s) and their respective spouses) of, and those living in the same household (whether related or not) of all employees of the foregoing entities, are not eligible. All applicable federal, state, local, and municipal laws and regulations apply. Void where prohibited or restricted by law. Each entrant who submits an entry must be the rightful owner of the profile and/or email account identified in the entrant's entry at the time of registration. **3. How to Play:** To participate in the Contest, entrants shall be provided three (3) methods of entry: the Online Method of Entry and the Product-Review Email Method of Entry. Online Method of Entry and Product-Review Email Method Entry will be referred to as "Entry(ies)" from this point on.

- a. **Online Method of Entry:** During the Contest Period, eligible participants can enter the Sweepstakes by following these steps: i) visit Abt.com ("Website") and direct to the product page of the product you purchased to provide a product review. After successfully submitting a product review and your feedback, you will automatically be entered into the Sweepstakes ("Online Entry"). Inappropriate comments in the product review will be disqualified at the sole discretion of Sponsor.
- b. **Product-Review Email Method:** To enter via this method you will complete a review through an email that is sent to the email address you used to purchase the item. The email address that is sending that Product-Review email is, [products@reviews.abt.com](mailto:products@reviews.abt.com). To be eligible for a given monthly random drawing, your email entry for this method must be submitted during the applicable Monthly Entry Period and received within seven (7) days later.

- c. **No-Purchase Necessary** Email Method: To enter via this method, please follow the following steps: (1) click on the following link: [www.abt.com/help/contact-us#email-us](http://www.abt.com/help/contact-us#email-us); (2) click on the 'Select a department' drop down menu; (3) select 'marketing'; (4) type your full name in the 'Name' field; (5) type your email address in the 'Email' field; (6) type your phone number in the 'Phone' field; (7) type "Entry for 2026 Review & Win Sweepstakes" in the 'Message' field; (8) click 'Submit'.

**4. General Rules:** By participating in the Contest, entrants agree to be bound by these Rules. In the event that there is a discrepancy or inconsistency between disclosures or other statements contained in any Contest materials, the terms and conditions of the Rules shall prevail, govern, and control. Return of prize notification as undeliverable may result in disqualification, and an alternate winner may be selected. Winner may waive his/her right to receive the prize. The prize is not assignable and is not transferable. No substitutions are allowed. The winner is solely responsible for reporting and payment of any taxes on prizes.
