Terms and Conditions

1. This Promotion is open to individual residents in the United States of America, over the age of 18 (“Participant”).
2. For the purposes of this Promotion, the “Participating Retailer” is any of the retailers listed at <https://rebate-promos/LGD26> (either online or brick and mortar unless otherwise specifically stated).
3. To qualify under this Promotion, Qualifying Purchases (as defined below) must be made within the period commencing on July 16, 2026 and concluding on August 26, 2026 (“Promotion Period”) from the Participating Retailer.
4. Under these Promotion Terms, a Promotion Product is any new (i.e., not used, refurbished or otherwise second hand) LG product detailed in Table 1 and/or Table 2 below. A “Qualifying Purchase” is a single transaction consisting of at least one (1) or more Promotion Products from any sub-category or sub-categories, with a limit of one (1) Promotion Products per sub-category, with the exception of the pedestal category, with a limit of two (2) Promotion Products per sub-category subject to compliance with Condition 6 below, for eligibility to receive a Rebate under this Promotion. Laundry combination units "Combo Units (Wash/Dry)" will be counted as two (2) Promotion Products.
5. Participants who make Qualifying Purchase(s) are eligible to claim a Virtual Mastercard® Prepaid Card with a value dependant on the selected Promotion Product purchase made in accordance with Table 1 and 2 below (“Rebate”) and subject to full compliance with these Promotion Terms. The maximum total Rebate(s) is capped at \$850.00 with up to ten (10) Promotion Products allowed for each Claim by a Participant, regardless of the number of Qualifying Purchases or Claims.
6. **Additional Bonus:** Where a Participant’s Qualifying Purchase(s) includes Promotion Products detailed in Table 1 and/or Table 2 below, the Participant will qualify for an Additional Bonus in addition to the Rebate specified in Condition 5. To qualify for the Additional Bonus, the Qualifying Purchase(s) for Promotion Products from the sub-categories listed below.  - v. Qualifying Purchase(s) consisting of one (1) Washer and one (1) Dryer will be eligible to claim an Additional Bonus of \$100.
 - vi. Qualifying Purchase(s) consisting of one (1) Washer, one (1) Dryer, one (1) Pedestal and one (1) Sidekick will be eligible to claim an Additional Bonus of \$150; or
 - vii. Qualifying Purchase(s) consisting of one (1) Washer, one (1) Dryer and two (2) Pedestals will be eligible to claim an Additional Bonus of \$150; or
5. The maximum Rebate value is capped at \$850.00 with up to two (2) Additional Bonus Categories permitted for each Claim by a Participant, regardless of the number of Qualifying Purchases or Claims and in compliance with these Terms and Conditions, provided that each Additional Bonus Category is from a separate product category as set out in Table 3 below, with no more than one (1) Additional
