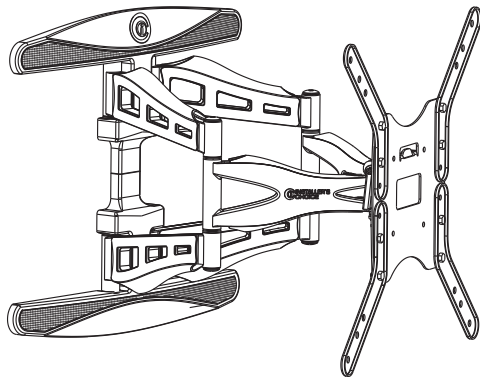

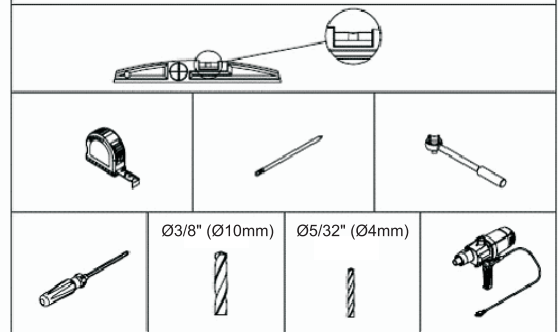

- For safe installation, the wall you are mounting to must support minimum 4 times the weight of the total load (the mount, the TV and all accessories).
- Do not use this product for any other application than originally designed.
- This product contains moving parts, please use with caution.
- When installing flat panel display, please do not damage electrical wiring or power source.
- The manufacturer will bear no responsibility for mounting to the vertical wall, or incidental or consequential damages arising thereof.

No wall anchors used(8).

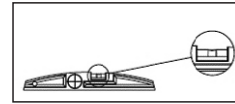
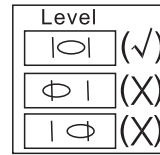
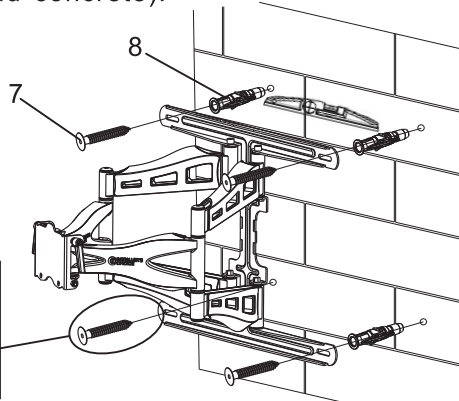
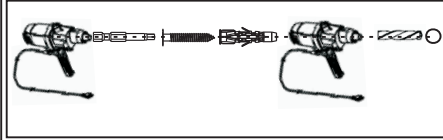
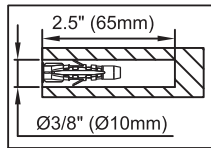

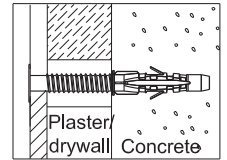
Step 1B

Use wall anchors (8).

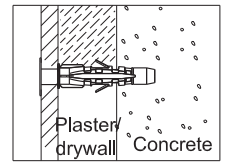

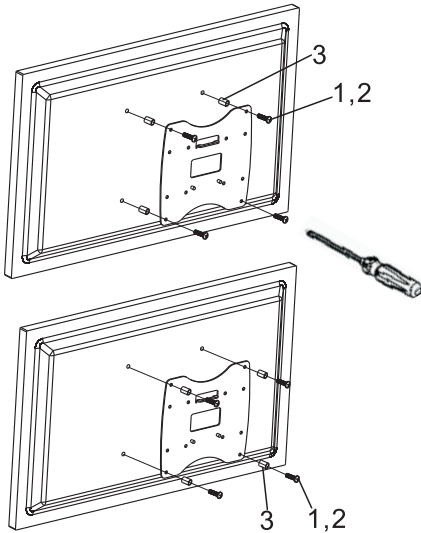

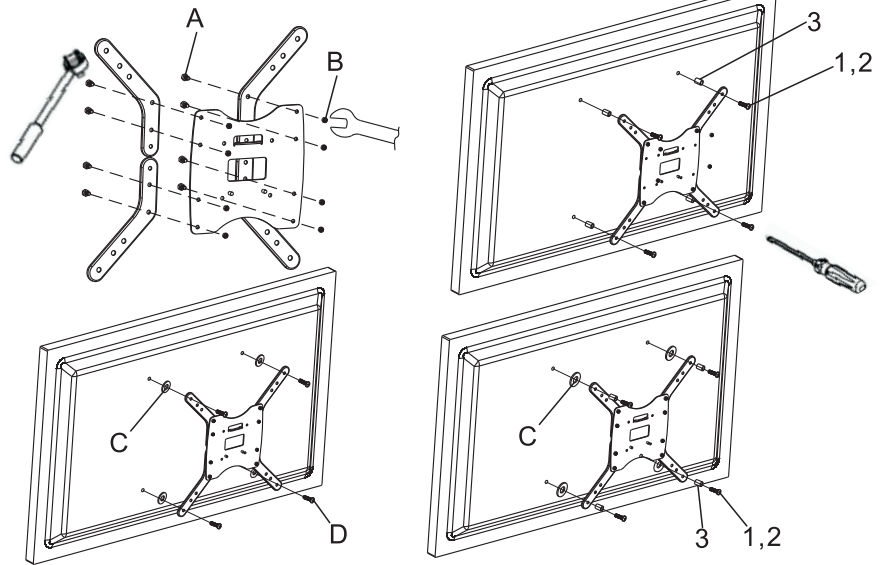

Mounting hole patterns $\leq 200 \times 200$ mm

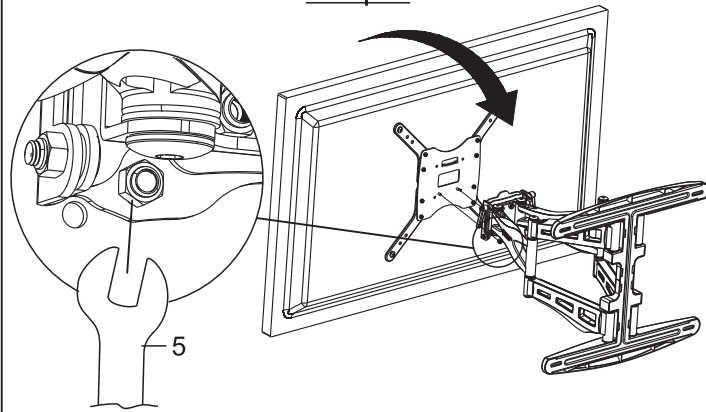

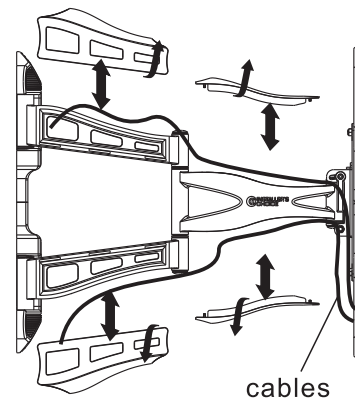
Mounting hole patterns $> 200 \times 200$ mm



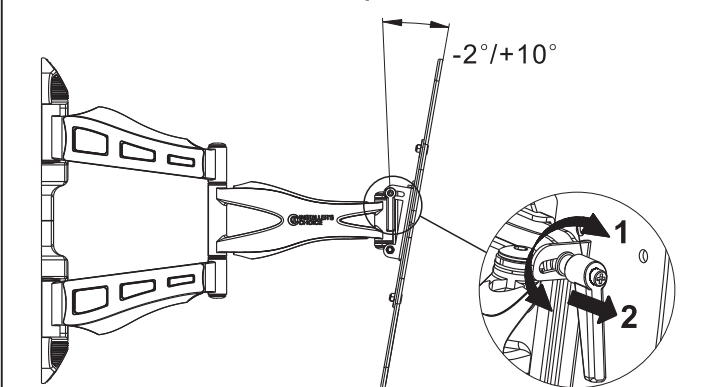

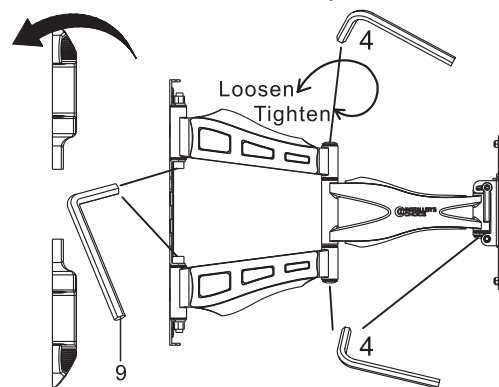
