Your Bang & Olufsen® product is warranted by:

All Bang & Olufsen products carry an international guarantee against defects in workmanship and materials for three years from the date of purchase. During which, Bang & Olufsen will repair any defect or malfunction in the product.

To warranty register a product one of the following steps must be completed: register online at www.bang-olufsen.com/beowarranty, complete/return the attached registration card to the address provided or call Bang & Olufsen at 1-800-532-0544. Registering a product does not replace the original sales receipt. Once registered, a Warranty Certificate will be sent to the address provided.

For service needs, deliver the product, prepaid, in the original/similar protected packaging, to an authorized Bang & Olufsen dealer or service station. The Warranty Certificate must accompany the product.

If the Warranty Certificate is not present or if the product has not been registered, present a reasonable proof of the date when the product was purchased and the following information:

- Product name and type
- Name and address of the Apple Store where purchased

The duration of any and all implied warranties arising under this contract or by operation of law is limited to three years from the date the product was first purchased.

This warranty is transferable with a transfer in ownership of the product for which warranty service is claimed, provided, however, that the warranty period begins to run from the first original date the product was purchased.

To the extent permitted by law, Bang & Olufsen disclaims and shall not be liable for any indirect, incidental or consequential loss, damage or inconvenience resulting from any defects or malfunctions or from incorrect installation. Improper or incorrectly performed modifications void this warranty. Under no circumstances shall Bang & Olufsen be responsible for any amount greater than the actual purchase price of the product.

Except to the extent prohibited under applicable law, all other warranties and conditions, express or implied, and whether arising by law, by statute, by course of dealing or trade practice, including implied warranties of merchantability, merchantable quality and fitness for purpose, are excluded and do not apply to this warranty. Where such a prohibition exists under applicable law, the provisions of this written warranty are in addition to, and not in modification of, or subtraction from, the statutory warranties and other rights and remedies contained in any applicable legislation.

By providing information to us you are consenting to the use of the information as described in this paragraph. International Warranty
