

Abt Electronics, Inc. “Picnic Time Cabernet Wine Tool Set” Giveaway – Official Rules

Eligibility: The Abt Electronics, Inc. “Picnic Time Cabernet Wine Tool Set” Giveaway (“the Giveaway”) is open to any legal resident of the fifty (50) United States and the District of Columbia, excluding Puerto Rico, **who is 21 years or older at the time of entry** and who is located in the United States. Each entrant must select the correct answer to a trivia question from multiple choices. After selecting the correct answer, the entrant will be prompted to provide his or her username, and entrant will then be placed into the pool of eligible entrants from which winners will be selected randomly.

All entries must be received by Sponsor no later than 3:00 p.m. (CST) on December 18, 2015.
